1) All Board must be paid monthly in advance, on the first day of each month. A late charge of \$20 will be charged on all board not received by the fifth (5th) day of each month. The monthly boarding charge is \$\_\_\_\_\_ per month. The owner grants a lien on the above named equine and tack for all unpaid charges. The animal owner warrants that to the best of his/her knowledge the animal has not been exposed to contagious or infectious diseases for 30 days prior to arrival of the horse on the premises of ARF for boarding.

2) Board runs from the first of the month to the end of the month. The animal owner agrees to give at least thirty-five days written notice, no later than the 25th day of the second to last month that board is needed, prior to departure. (For example,

written notice given at any time between September 1st and September 25th means that the last full month of board desired is October. Full Board must be paid through October. Initial\_\_\_\_\_

3) The animal owner agrees to pay all medical, hospital, veterinarian and incidental/consequential expenses related to the treatment of the boarding animal. If Angelica Run Farms, Inc., discovers that the animal is ill or injured, Angelica Run Farm, Inc. will notify the animal owner at once and request instructions. If the owner cannot be reached or fails to respond to the request, or the horses' health or well being is placed in imminent danger which required immediate action, it is agreed that the employees or agents of Angelica Run Farms, Inc shall have the right to use her/his best judgment on how to proceed to protect the animal's health and welfare.

4) Angelica Run Farm, Inc. and its employees and agents shall not be liable for damages which may accrue from any cause growing out of or as a result of the boarding of the animal including but not limited to loss by fire, theft, running away, wind, flood, or other inclement conditions, or injury or death to persons, animals, or damage to property.

5) All rates are subject to increase.

6) In the event someone other than the owner calls for the horse, such person shall have written authority signed by the owner of the horse to obtain the horse and sign a written release of Angelica Run Farms, Inc.

7) The owner agrees to abide by all the rules and regulations of the stable which are posted, and to inform all agents and invited guests that such rules are posted.

8) This agreement consists of both this document and a written release of Angelica Run Farms, Inc., its agents and employees, from responsibility of engaging in the inherently dangerous activities of handling equines, signed separately by the equine owner on the \_\_\_day of \_\_\_\_\_, 20\_\_\_. These two documents comprise the entire agreement between the two parties.

9) The animal owner releases and expressly agrees to identify Angelica Run Farms, Inc, and its employees and agents from any and all claims, demands, actions or suits at law or in equity, of any kind in nature, including negligence, by anyone the animal owner has authorized express or implied, be they agent, guest, independent contractor or any other capacity, to handle the animal on<sup>3</sup> the premises or authorized or invited to enter on the premises for an equine activity or activity collateral to handling an animal.

10) No boarding client of Angelica Run Farm, Inc. may switch to boarding with another business operating at the premises of Angelica Run Farm without first removing their horse to another farm for the term of one year prior to returning to

board in the stables or stalls another competing business operating at the premises of Angelica Run Farm. Waiver or any breach of this agreement shall not be held to be a waiver of any other or subsequent breach of this agreement. This agreement shall remain in effect until subsequently revoked in writing by the parties.

For Angelica Run Farms, Inc RELEASE OF ANGELICA RUN FARMS, INC., ITS' AGENTS AND EMPLOYEES FROM RESPONSIBILITY FOR MY PARTICIPATION IN THE INHERENTLY DANGEROUS ACTIVITY OF HANDLING EQUINES.

I, \_\_\_\_\_, declare that I am authorized by \_\_\_\_\_, who is the owner of the animal named \_\_\_\_\_ to handle the named animal under the terms and conditions set forth in the Boarding Stable Agreement between the above named owner and Angelica Run Farm Inc, its employees and agent's. I agree that in consideration for being permitted to participate in the inherently dangerous activity of engaging in equine activities on the premises of Angelica Run Farms, Inc., I agree for myself, my spouse, legal representatives, heirs and assigns to release, waive, and discharge Angelica Run Farms, Inc., its officers, employees and agents, and any land owners upon which the facilities of Angelica Run Farms, Inc. operates, from all liability for any and all loss or damage, and any claim or damages resulting there from, on account of injury to my person or property, even injury resulting in my death, whether caused by the negligence of the releases or otherwise while I am engaged in any equine activities whatsoever, and any activities collateral to such activities while on the premises of Angelica Run Farms, Inc. I assume full responsibility for the risk of bodily injury, death or property damage whether due to the negligence of releases or otherwise while on the premises. I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as possible as permitted under the law of the Commonwealth of Virginia, and pursuant to the Equine Activity Liability Act, Title 3.1 under Chapter 27.5, including all of but not limited to Sections 3.1-796.130 through 3.1 796.133 of the code of Virginia 1959, as amended. I have knowingly executed this waiver of my rights to sue and agree to assume all risks except those specifically enumerated as exempt under this subsection. I understand that there are inherent risks in equine activities, including but not limited to (i) the propensity of an equine to behave in dangerous ways which may result in injury to myself or others, or to property; (ii) the inability to predict an equine's reaction to sound, movements, objects, persons, or animals; and (iii) surface or subsurface conditions. This waiver shall remain valid unless expressly revoked by myself, in writing.
